

Introduction

The past couple of years have brought about significant disruptions to how work is conducted. This has necessitated the rapid adoption of themes such as hybrid work arrangements, immersive collaboration, and employee wellbeing.

However, while the employees welcomed the shift to flexible work, it has led to employee disengagement and detachment with the organizations, which are now functioning on a different scale. As a result, there is severe employee burnout, dwindling organizational citizenship behavior, and increasing voluntary turnover.

Enterprises must therefore inculcate norms and culture to increase a sense of commitment to the team and belongingness to the organization, particularly as employees prefer distributed work with anytime, anywhere, and any device access to natural communication and seamless collaboration. These evolving employee demands and needs have led to the adoption of technologies such as cloud-based WCC services, Intranet 2.0, and more significantly metaverse-based immersive communication and collaboration. To meet the rising expectations, the onus now lies with the enterprises to evaluate business outcomes, identify potential challenges, select appropriate partners, and create an employee-engaging workplace.


