## Background of the research

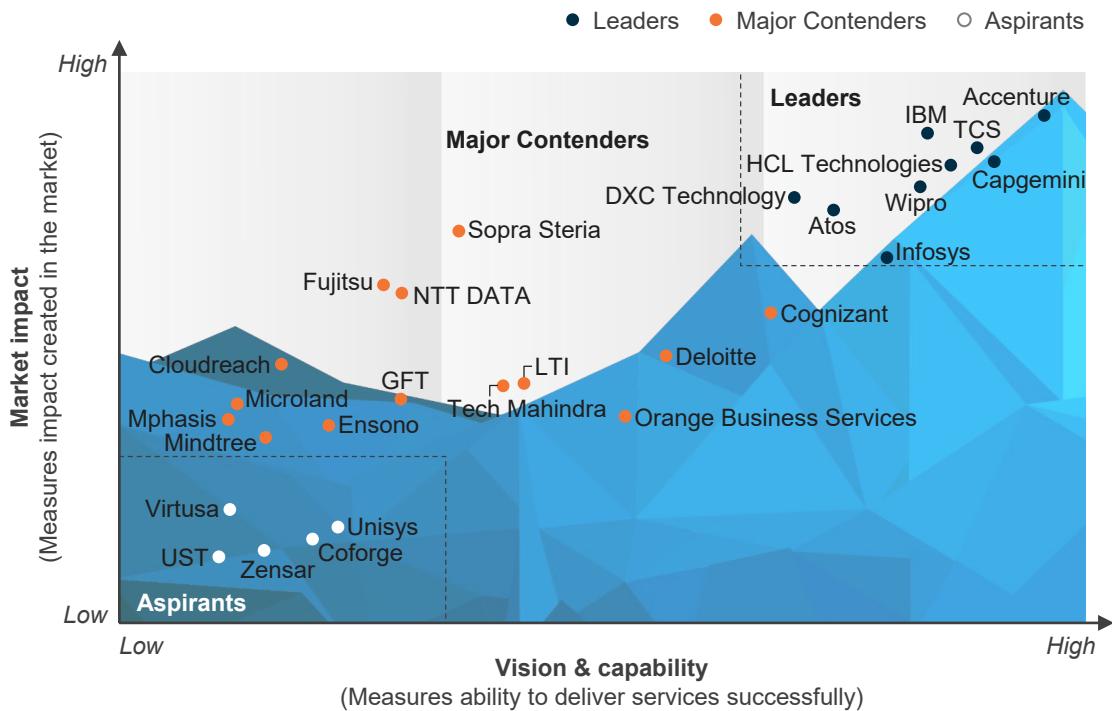

**Strengths**
