

## **Background of the research**

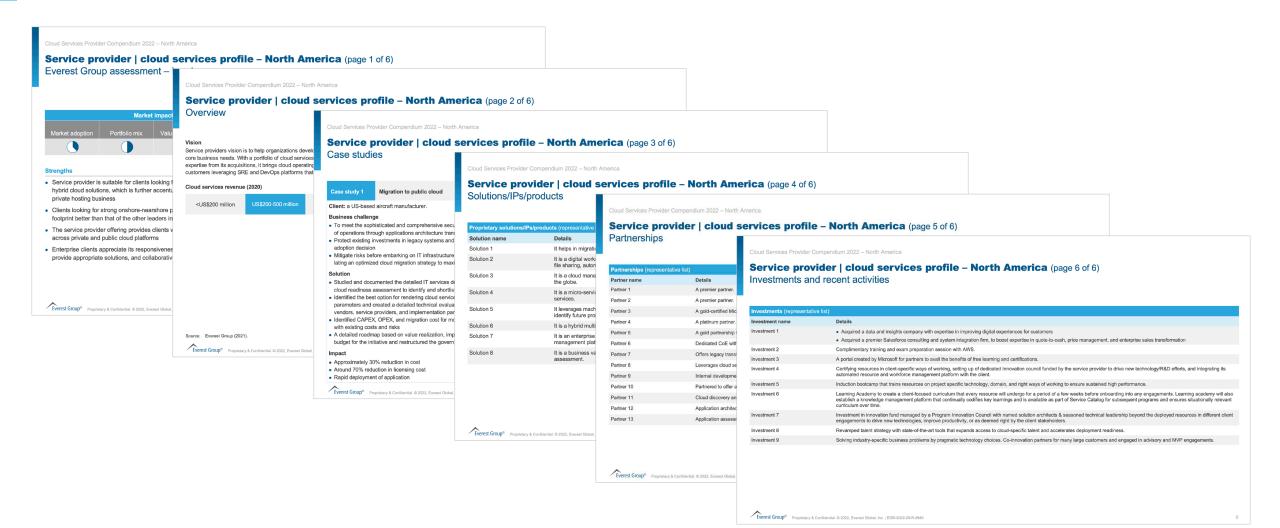
