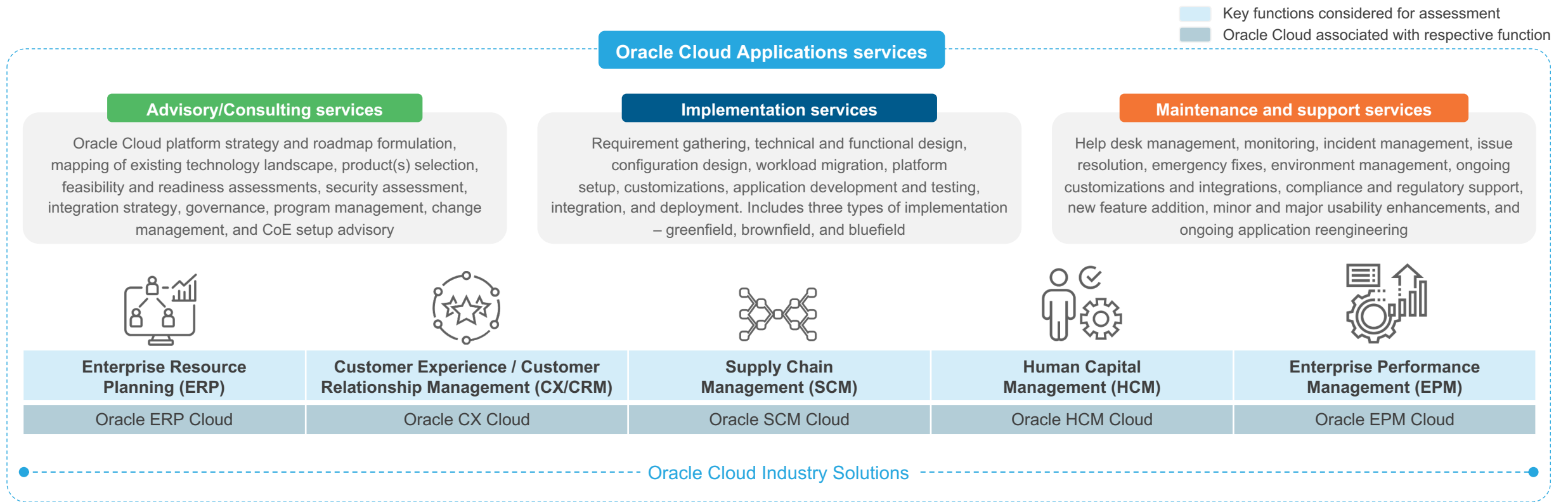

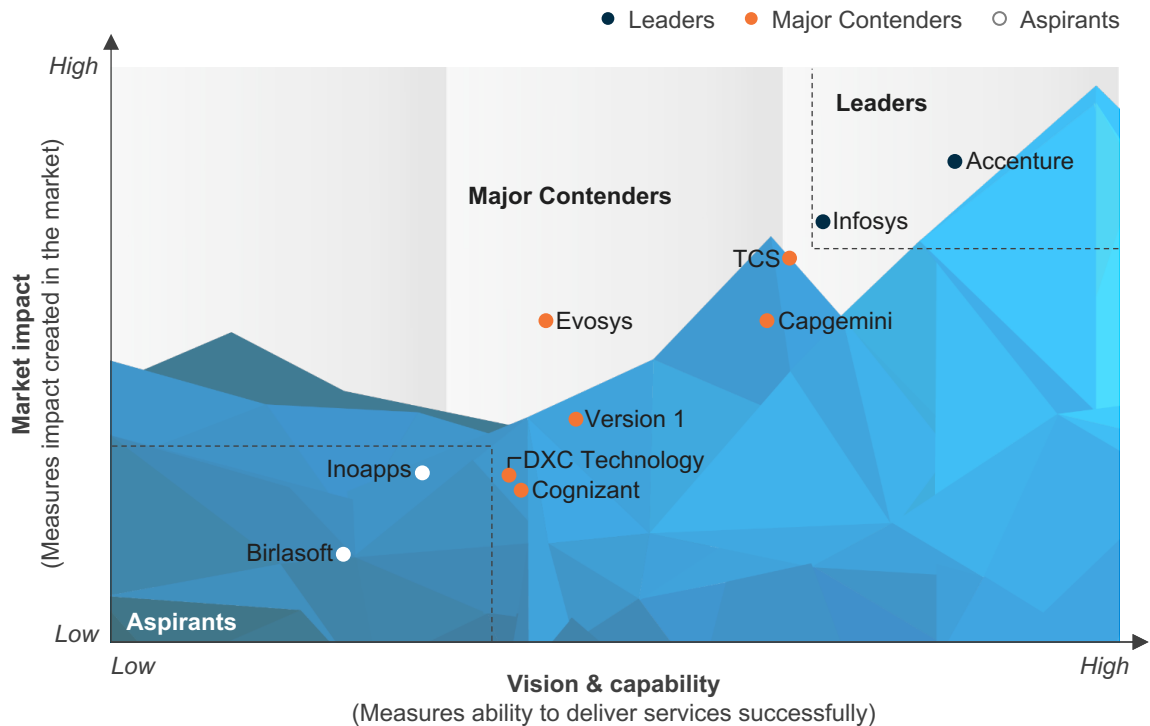

**Strengths**

- Provider 1 is a fitting choice for large enterprises seeking multi-country, global OCA implementation services
- It has good coverage across the entire OCA product portfolio and is thus suitable for buyers looking to drive transformation across LoB engagements

**Limitations**

- It needs to further scale its delivery footprint and onshore/nearshore presence in the emerging markets to better support its clients for global rollouts and position itself as a strategic partner
