Background and scope of the research

Background

The global services market exhibited remarkable growth in 2022, reaching a value of approximately US\$275 billion. However, the momentum slowed down in 2023, with the market's revenue expanding only marginally by 3-5% by the end of 2023 (a considerable decrease from the ~12% growth in 2022) reaching almost US\$285 billion. Moreover, the global services market saw a subdued increase in headcount throughout 2023, with an approximate net addition of ~300,000 Full-time Equivalents (FTEs) to the workforce across various regions

Global organizations are strategically diversifying their location portfolio across the globe, expanding into both established and emerging locations for service delivery. In today's volatile landscape, characterized by conflicts such as Israel-Hamas, Israel-Iran, and Russia-Ukraine, coupled with a global macroeconomic slowdown and geopolitical uncertainties surrounding elections, the need for a wellbalanced and diversified location mix has never been more critical. Everest Group supports enterprises and service providers in choosing the best locations by tailoring the needs of the client to our expertise This report provides an extensive assessment of the global locations and center landscape and adoption trends as of 2023 and elaborates on key 2024 priorities for leaders along with action steps for building a successful location mix

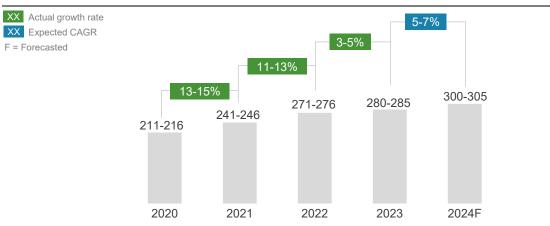

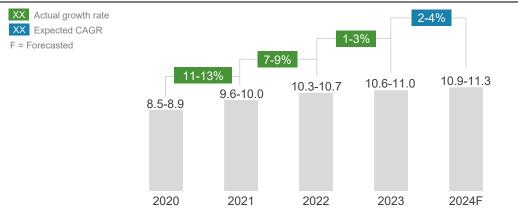

Global services market revenue, 2020-24F; US\$ billion

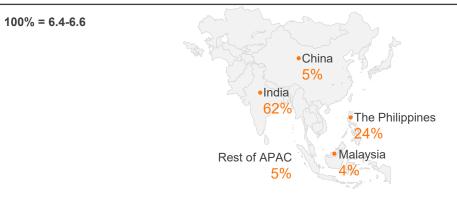


Global services market headcount, 2020-24F; number of FTEs (in millions)
