Background of the research

- Everest Group interacted with 50+ enterprises over the previous 18-24 months about their ESG posture and cybersecurity role. They have stressed the significance of incorporating cybersecurity into their ESG structure to manage the risks posed by cybersecurity to their ESG initiatives
- The imposition of new government requirements drives the establishment of comprehensive incident response and reporting, including transparency toward stakeholders regarding enterprise cybersecurity posture, that requires enterprises to be highly adaptive in evolving threats landscape
- Enterprises have ESG mandates, but they overlook cybersecurity as an enabler to achieving these mandates. A robust cybersecurity framework can protect investor values, meet compliance requirements, promote customers' trust, and mitigate sole reliance on insurance
- This report discusses how to leverage MDR services to address ESG initiatives and seize opportunities to minimize the financial material risk that enterprises may face to their sustainability roadmap

- There are 15+ providers with HRO transaction experience in the global market


MDR for sustainability

They need to comprehend the potential impact of MDR services on specific ESG initiatives, combine ESG materiality assessment and industry-based cyber risk exposure to understand enterprise security posture, carefully choose MDR service providers, and continually monitor and refine MDR services
- MDR service providers must adopt an operating model aligned with ESG principles before assisting their clients in achieving their ESG objectives
